# **Canada Table Update**

Elsipogtog is continuing to meet with Canada as part of our exploratory table to discuss the possibility of negotiations based on the recognition of Elsipogtog's Aboriginal title, rights and treaty rights as members of the Mi'kmaq Nation. Due to the ongoing restrictions on travel imposed by COVID-19, our meetings with Canada have taken place by telephone or video conference. The last call took place on June 29th, 2021.

Elsipogtog and Canada are looking to establish an inclusive and effective process to discuss issues of importance to the Mi'gmaq in general and Elsipogtog specifically.

### **Types of Claims**

### Comprehensive (Land) Claim

A comprehensive land claim is when an Indigenous Nation enters negotiations with Canada and the province/territory to develop a modern treaty that recognizes that particular nation's rights and title to land and resources. A modern treaty may also include provisions relating to self-government..

### Aboriginal (Title) Claim

Aboriginal title refers to the inherent Aboriginal right to land or a territory. Courts have defined Aboriginal title as a beneficial property interest in land which arises by virtue of Indigenous peoples' use and occupation of their ancestral lands prior to the arrival of Europeans, and which is held collectively by the Indigenous group in question. Aboriginal title is protected under section 35(1) of the Constitution Act. 1982.

#### Specific (Land) Claim

What are specific claims? Specific claims deal with past wrongs against First Nations. These claims (made by First Nations against the Government of Canada) relate to the control of First Nations lands and assets to fulfill historic treaties and other agreements.
